Financial Update

Legislative Update

Dr. Steggall reviewed the open enrollment bill, which passed with a vote of 88-69 and has been reported to the Senate for consideration. She also reported on the increase in the minimum teacher salary beginning in the 2025-26 school year, stating that the district's approved salary schedule meets all new requirements.

2025-2026 School Calendar

Dr. Steggall stated that staff approved the calendar option with Friday night graduation (May 15th) to avoid conflicts with Mother's Day. Two "Staff Work Days" were removed during the school year, adding one at the end (May 21st) in the afternoon.
